MEMORANDUM FOR THE RECORD

Subj: AUTHORIZATION FOR TDY ENTITLEMENTS FOR RESERVE COMPONENT
INDIVIDUAL AUGMENTEE ORDERS AT ONE GEOGRAPHIC LOCATION
FOR GREATER THAN 180 DAYS

1. United States Fleet Forces Command (USFF) N1 is the Executive Agent for Individual Augmentees (IA) and as the first GO/FO/SES in the IA program chain of command is authorized to grant extensions of TDY entitlements in accordance with references (a) and (b). Reserve Component (RC) new orders and extensions in support of contingency operations at one geographic location are authorized as follows.

a. Between 180 days up to and including 365 days: For FY 13 and FY 14, RC IAs who would receive full TDY entitlements are authorized per USFF N1. RC IAs who receive only the incidental expenses (IE) portion of per diem are authorized under reference (b).

b. Greater than 365 days up to 730 days: For FY 13 and FY 14, RC IAs who would receive full TDY entitlements shall be authorized on a case-by-case basis. Authorization requests for the second year TDY entitlement shall include appropriate justification and be routed through the appropriate chain-of-command to USFF N1 for final decision. RC IAs who receive only the IE portion of per diem are authorized up 730 days per reference (b).

c. Greater than 730 days: Authorization requests shall include appropriate justification and be routed through the appropriate chain-of-command via USFF N1 to Assistant Secretary of the Navy - Manpower & Reserve Affairs (ASN-M&RA) for final approval.

2. References (a) through (e) provide guidance and policy related to the authorization of per diem/actual expense authorization (AEA) in excess of 180 days in one location, for RC on active duty and Active Component (AC) in support of

contingency operations. Authorization for authority in regard
to Navy IAs delegated down from ASN(M&RA) will not be delegated
below the USFF N1 level.
